# **ORDINANCE NO. 2022-04**

AN ORDINANCE AMENDING ORDINANCE 2012-05, BUILDING PERMIT FEE SCHEDULE, OF THE CITY OF FRIENDSVILLE, TENNESSEE AS SET FORTH IN APPLICABLE CHAPTERS OF THE CITY CHARTER AND THE <u>TENNESSEE CODE ANNOTATED</u>.

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF FRIENDSVILLE, TENNESSEE, THAT:

Ordinance 2012-05 is hereby amended as follows:

#### SECTION 1.

Ordinance 2012-05, Building Permit Fee Schedule, is hereby amended by deleting the fee language contained therein and substituting the attached Fee Schedule in lieu thereof:

### **SECTION 2.** SEVERABILITY

Should any section or provision of this ordinance be declared by the courts to be unconstitutional or invalid, such decision shall not affect the validity of this ordinance as a whole, or any part thereof, other than the part so declared to be unconstitutional or invalid.

# SECTION 3. CONFLICTING ORDINANCE

Any equally or less stringent provisions of any previously adopted ordinance which provisions are the same as or in conflict or at variance with the provisions or this ordinance are hereby amended by deleting the same, rendering the same of no further force and effect.

### **SECTION 4. EFFECTIVE DATE**

This ordinance shall take effect from and after its final passage and publication, the public welfare requiring it.
